IFS Coatings has Environmental Product Declarations (EPDs) for each of our architectural grade, performance powder coating products.

EPDs provide a third party verified, transparent look at a product, its ingredients and its impact across the entire life cycle. Similar to a nutritional label, an EPD is used to communicate information about the potential environmental and human health impacts of a product.

All IFS Coatings architectural grade, performance powders come with an EPD.

They come in thousands of colors and effects as well as custom colors.



Why Is IFS Coatings The Environmentally Responsible Choice?

IFS high performance powder coatings are the environmentally responsible choice because:

- There are no solvents or Volatile Organic Compounds (VOCs) in IFS powder coatings.
- Any over spray can be reclaimed, recycled and reused.
- No toxic waste is created in manufacture or application.
- They will perform over non-chrome pretreatment to AAMA 2605 levels.
- They do not require a chrome based primer, or in fact any primer when used on aluminum.
- They outperform equivalent liquid
 architectural paints in every LEED category.
- They are recognized and recommended by the EPA.
- They each come with an EPD and contribute to LEED points.
